Treasurer's Report:

Joan Sanford was placed on the signature of checks at Regions Bank. Zak Wonson's name was removed.

Anne Rader read the Treasurer's Report. There is a current balance of \$4,333.21, In December we received \$485.00 in Memberships and Tournaments. Our expenses were \$440.00 for Maintenance and Office Supplies (New Printer). Motion to accept report, seconded by Dennis and Vaughn, report approved.

Completed Business: Leisure Services

- Lock on Electric light door for courts changed, keys to remain same
- Light replaced in parking lot was replaced

Unfinished Business:

- Painting of yellow curbs to be done by the city maintenance in the Spring. It was mentioned by Vaughn that the wood needs to be repaired before it is painted.
- There is a request to contribute some money to the Pizza Party on Dec 21, 2023. The amount paid by Janet was around \$109. Anne mentioned she has the receipt but didn't bring it. Anne Rader made a motion to pay the full amount of the receipt to Janet. It was clarified that it would be a one-time payment. Tom seconded the motion. Motion was approved.
