**Treasurer's Report:**

Anne Rader read the Treasurer's Report. In January we spent \$1,134.97 on Miscellaneous (Tournaments Prizes, Fun Day, Food & Donuts, etc). We paid Leisure Services \$300 for 20 Memberships. We brought in this month \$633.00 mostly Membership dues. We've got a \$150 Donation from 3 groups of Members specifically for the Master. If anybody wants to donate, please specify where you want the money to be spent. Currently, we have \$1,640.00 remaining from 2023 Sponsor Donations. We have \$2,235.00 remaining for any activity we choose to do and it is separate from sponsor money. Our current bank balance is \$4,663.00. Motion to accept the report, seconded by Dennis and Vaughn, report approved.

- *Mardi Gras – Feb 13<sup>th</sup> at 5 pm the Parade starts at 7 pm. After that whoever wants to play can come back to the club. The parade goes from the Ocean to the Shuffleboard. Scott & Judy and Mike Beall donated their golf carts for the parade and the Club bought 1000 beads.*
- *Master Tournament - \$200 given by ND and \$300 by our club, DJ is being donated by Stan. A motion was proposed to give an additional \$500 for the Banquet over the \$300 already approved. Janet commented that everything was donated except the food. Janet donated the décor, and other members have donated money. We will have 80 participants. The motion was approved.*
- *Feb 29 and March 1<sup>st</sup> we will have a tournament at Coronado/Mainland and Bonnie will be the director*
